## Determination of Customs Values of Printers (HS Code 8443.3220, 8443.3210, 8443.3230 & 8443.3290) Under Section 25-A of the Customs Act, 1969

(VALUATION RULING NO. 875/2016)

No. Misc/21/2007-VII (Part-III)

Dated: June 22, 2016

In exercise of the powers conferred under Section 25-A of the Customs Act, 1969, Customs values of Printers are determined as follows:

- 2. **Background of the valuation issue:** The Customs values of Printers were determined under Section 25-A of the Customs Act, 1969 vide Valuation Ruling No.205/2009 dated 30-12-2009. A number of representations were received to determine the customs values afresh in the light of existing international market prices, according to the different brands and models. Therefore an exercise to determine customs values of Printers afresh in terms of Section 25-A of the Customs Act, 1969 was initiated.
- 3. Stakeholders' participation in determination of Customs values: A meeting for the determination of customs values of Printers with stakeholders was scheduled on 24-05-2016. The meeting was attended by a few importers. On the request of M/s Pakistan Computer Association Islamabad, another meeting was scheduled on 07-06-2016. The meeting was attended by a number of importers, including representatives of M/s. ABM Data Systems (Private) Ltd., M/s. Mushko Electronics Private Ltd etc.
- 4. During the course of meeting, the importers were of the view that the values of Printers were determined since long. They asserted that a number of new models have been introduced by all manufacturers but there is no uniform customs value for such models. M/s. Mushko, representative of HP Printers, submitted their proposals along with evidences of import. M/s. ABM Systems (Private) Ltd., also submitted their commercial invoices and sales tax invoices of their brands namely Epson Printers. It was also agreed during the stakeholders' meeting that market survey would also be conducted regarding those brands which are available in the market and are being regularly imported.
- 5. Method adopted to determine Customs values: Valuation methods given in Section 25 of the Customs Act, 1969 were followed to arrive at customs values of Generators. Transaction value method provided in Section 25 (1) was found inapplicable because the requisite information was not available. Identical / similar goods value methods provided in Section 25(5) & (6) were examined for applicability to the valuation issue in the instant case which provided some reference values of the subject goods but the same could not be exclusively relied on due to wide variation in declared values of subject goods. Thereafter, market enquiry as envisaged under section 25(7) of the Customs Act, 1969, was conducted. The computed value method as 1910 provided in Section 25(8) of the Customs Act, 1969, could not be applied as the conversion costs from constituent material at the country of export were not available. Online values of subject approved were also obtained. All the information so gathered was evaluated and analyzed for the princes of determination of customs values. Consequently, the Customs values of different type of printers have been determined under Section 25(9) of the Customs Act, 1969.
  - 6. **Customs values for Printers:** Printers as *specified herein shall* be assessed to duty/ taxes at the Customs values given in the following tables.-

- 7. These printers are being manufactured in different places across the globe depending on economy of scale, regional supply chain and consumption in the specific market. However, due to brand loyalty, these are usually traded on the basis of brand name and specifications; therefore, it was considered prudent to base the values on 'all origin basis' in the Ruling. Furthermore, this Directorate General has endeavored to incorporate in the ruling different types and specifications of printers as being traded / imported and are currently available in the market. The printers other than the ones specified in the Ruling may be assessed under section 25 of the Customs Act, 1969. If the value dispute regarding printers not available in this ruling is not resolved at Collectorate level, the same may be forwarded to this Directorate General for suitable advice.
- 8. In cases where declared/ transaction values are higher than the Customs values determined in this Ruling, the assessing officers shall apply those values in terms of Sub-Section (1) of Section 25 of the Customs Act, 1969. In case of consignments imported by air, the assessing officer shall take into account the differential between air freight and sea freight while applying the Customs values determined in this Ruling.
- 9. **Validity of this Valuation Ruling:** The values determined vide this Ruling shall be the applicable Customs value for assessment of subject imported goods until and unless it is rescinded or revised by the competent authority in terms of Sub-Sections (1) or (3) of Section 25-A of the Customs Act, 1969.
- 10. **Revision of the value determined vide this Valuation Ruling:** A revision petition may be filed against this Ruling, as provided under Section 25-D of the Customs Act, 1969, within 30 days from the date of issue of this ruling, before the Director General, Directorate General of Customs Valuation, 7<sup>th</sup> Floor, Custom House, Karachi.
- 11. The Collectors of Customs may kindly ensure that the values given in the Ruling for the given description of goods are applied by the concerned staff without fail. Any anomaly observed may kindly be brought to the notice of this Directorate General immediately. The Customs values determined in the ruling are for the descriptions and specifications as mentioned in the Table above. HS codes are mentioned for illustrative purposes only so that VR values are made accessible to the assessing officers. The assessment shall be finalized in the correct classifications after fulfilling all formalities relating to importability or any other certifications required thereon. In addition to this, it is further necessary to verify that there is no misdeclaration of any sort or violation of Import Policy Order or Section 15 of the Customs Act, 1969 or any other law in vogue therein.
