Determination of Customs Values of Tyres & Tubes Under Section 25-A of the Customs Act, 1969

(VALUATION RULING NO. 1236/2017)

No. Misc/08/2005-III

In exercise of the powers conferred under Section 25-A of the Customs Act, 1969, the Customs values of Tyres & Tubes are determined as follows:-

2. **Background of the valuation issue:** The customs values of Tyres & Tubes of various sizes / brands were determined under Section 25-A of the Customs Act, 1969 vide Valuation Ruling No 985/2016 dated 30.11.2016, followed by correction dated 06.02.2017. Different stakeholder has requested to determine customs values in line with values prevalent currently international market. Therefore, an exercise was initiated in terms of Section 25-A of the Customs Act, 1969 to determine customs values of subject goods afresh in the light of existing international market prices.

3. **Stakeholders' participation in determination of Customs values:** Meetings with stakeholders were scheduled on 02.11.2017, 16-11-2017 28.11.2017 and 05-12-2017. The stakeholders were requested to furnish the following documents before or during the course of above said meetings:-

- A. Invoices of imports during last three months showing factual value.
- B. Websites, names and E-mail addresses of known foreign manufacturers of the item in question through which the actual current value can be ascertained.
- C. Copies of contracts made / LCs opened during the last three months showing the value of item in question.
- D. Copies of Sales Tax Invoices issued during last four months showing the values of supplies (excluding duty and taxes) to substantiate their contentions.

During the course of meetings, the importers and local manufactures repeatedly agreed to come up with a joint proposal on certain type and size of tyres but no such document was submitted till the issuance of this ruling. Their individual proposals had significant variance; importers have requested for further downward revision, whereas local manufactures, have contended that tyre and tube prices have significantly appreciated owing to an increase of approximately ten per cent in the international market. They also contended that the values of certain type of tyres have gradually been decreased giving an undue advantage to importers. The issue of ratio of value of tube imported separately from the tyre was also discussed threadbare; manufacturers of tubes wanted to increase the ratio from five to at least eight per cent whereas

importers contended that giving such an advantage to importers of tyres brought without tubes would be significant and would compromise government revenue on the one hand and increase the tube values disproportionately.

4. Method adopted to determine Customs values: Valuation methods given in Section 25 of the Customs Act, 1969 were followed to arrive at customs values of Tyres & Tubes. Transaction value method provided in Section 25 (1) was found inapplicable because the requisite information was not available. Identical / similar goods value methods provided in Section 25(5) & (6) were examined for applicability to the valuation issue in the instant case which provided some reference values of the subject goods but the same could not be exclusively relied on due to wide variation in declared values of subject goods. Thereafter, market enquiries as envisaged under section 25(7) of the Customs Act, 1969, were conducted. All the information so gathered were evaluated and analyzed for the purpose of determination of customs values. Consequently, the Customs values of Tyres & Tubes have been determined under Section 25(7) of the Customs Act, 1969.

5. Customs Values of Tyres and Tubes : Customs values of Tyres & Tubes *hereinafter specified*, shall be assessed to duty/taxes on the Customs values mentioned as at Annexure (Page 01 to 08), which forms integral part of this Valuation Ruling along with following conditions:-

- i. *If a radial tyre is imported which is not covered in this Ruling and whose specifications are similar to normal tyre except for being radial, such tyres may be assessed at 25% higher than the normal tyre.*
- ii. *Where only tyres are imported, other than tubeless, deduction of 6% shall be allowed on Ruling value. Conversely if tube of a tyre specified in the Ruling is imported, the values shall be assessed at 6% of the Tyres value. However, two and three wheeler's tube shall be assessed at 15% of the value of the Tyre if imported separately.*
Value of tyres with different "Ply" shall be assessed by adding or subtracting from the determined value @ 5% Per Two Ply Rating.
Discount of 5% is admissible for import of Tyres & Tubes through Land Route on C&F values determined by this Directorate General.

6. In cases where declared / transaction values are higher than the customs values determined in this Ruling, the assessing officers shall apply those values in terms of Sub-Section (1) of Section 25 of the Customs Act, 1969. In case of consignment imported by air, the assessing officer shall take into account the differential between the air freight and sea freight while applying the customs values in this ruling.

7. Validity of this Valuation Ruling: The values determined vide this Ruling shall be the applicable customs value for assessment of subject imported goods until and unless it is rescinded or revised by the competent authority in terms of Sub-Sections (1) or (3) of Section 25-A of the Customs Act, 1969.

8. Revision of the value determined vide this Valuation Ruling: A revision petition may be filed against this Ruling, as provided under Section 25-D of the Customs Act, 1969, within 30 days from the date of issue of this ruling, before the Director General, Directorate General of Customs Valuation, 7th Floor, Custom House, Karachi.

9. The Collectors of Customs may kindly ensure that the values given in this Valuation Ruling for the given description of goods are applied by the concerned staff without fail. Any anomaly observed may kindly be brought to the notice of this Directorate General immediately. Customs values determined in the ruling are for the description and specification as mentioned in this Valuation Ruling. HS Codes are mentioned for illustrative purposes so that valuation ruling values are made accessible to the assessing officers. The assessment shall be finalized on the basis of correct classification after fulfilling requisite formalities related to importability or any other certification required thereon. In addition to this, it is further necessary to verify that there is no mis-declaration of any sort or violation of Import Policy Order or Section 15 of the Customs Act, 1969 or any other law in vogue therein.

10. This Valuation Ruling supersedes Valuation Ruling No. 985/2016 dated 30.11.2016 read with correction dated 06.02.2017
