DETERMINATION OF CUSTOMS VALUES OF LOW-END BRANDS SHOES, SLIPPERS, SANDALS, CHAPPALS AND JOGGERS UNDER SECTION 25-A OF THE CUSTOMS ACT, 1969

(VALUATION RULING NO. 1405/2019

NOMISC/01/2013-D 2534

In exercise of the powers conferred under Section 25-A of the Customs Act. 1969. the Customs values of Low-end Brands Shoes, Slippers, Sandals, Chappals and Joggers are determined as follows: -

- 2. Background of the valuation issue: Customs values of Low-end Brands Shoes, Slippers, Sandals, Chappals and Joggers were earlier determined through Valuation Ruling No.902/2016 dated 08-08-2016 & Order in Revision dated 30-09-2016. The values given in said VR, being more than three years old, needed redetermination, keeping in view price trends in international markets. Therefore, an exercise to determine the Customs values of the subject goods under Section 25-A was initiated in this Directorate General.
- 3. Stakeholders' participation in determination of values: Meetings with stakeholders were convened on 12-09-2019, 16-09-2019 which was attended by the importers, representative of All Pakistan Customs Agent's Association & FPCC&I. The importers contested that value of shoes in CHinternational market has decreased substantially due to severe competition and therefore, the values given in VR be decreased accordingly. Few importers submitted documents, such as Performa invoices, copies of G.Ds, filed with China Customs, Sales Tax invoices etc. to substantiate their claims. All the claimants so submitted there examined and compared with imports data as well as market prices.
 - 4. Method adopted to determine Customs values: Custom Valuation methods given in Section 25 of the Customs Act, 1969 were applied in sequential order to address the valuation issue at hand. Transaction value method under Sub-Section (1) of Section 25 of the Act ibid was found inapplicable because requisite information under the law was not available. Identical and similar goods valuation methods provided in Sub-Sections (5) and (6) of Section 25 of the Customs Act, 1969 provided some reference values but due to wide variation and suppressed declarations, the same could not be relied upon. In the sequential order this office then resorted to conduct a market inquiry and, consequently, Deductive Value Method under Sub-Section (7) of Section 25 of the Customs Act, 1969, was applied to arrive at the assessable Customs values of the subject goods, being most appropriate for the purpose.

5. Customs values for Low-end Brands Shoes, Slippers, Sandals, Chappals and Joggers: Low-end Brands Shoes, Slippers, Sandals, Chappals and Joggers hereinafter specified shall be assessed to duty/ taxes on the Customs values given against them in the Table below:

- 6. In cases where declared / Transaction values are higher than the Customs value determined in this Ruling, the assessing officer shall apply those values in terms of Sub-Section (1) of Section 25 of the Customs Act, 1969. In case of consignments imported by air, the assessing officer shall take into account the differential between air freight and sea freight while applying the Customs values determined in this Ruling.
- 7. Validity of this Valuation Ruling: The value determined vide this Ruling shall be the applicable Customs value for assessment of subject imported goods until and unless it is rescinded or revised by the competent authority in terms of Sub-Sections (1) or (3) of Section 25-A of the Customs Act, 1969.

- **8. Review of the value determined vide this Valuation Ruling:** A Revision Petition may be filed against this Ruling, as provided under Section 25-D of t Customs Act, 1969, within 30 days from the date of issue, before the Director General, Directorate General of Customs Valuation. 7th Floor, Custom House, Karachi.
- 9. The Collectors of Customs may kindly ensure that the values given in the Ruling for the given description of goods are applied by the concerned staff without fail. Any anomaly observed with respect to PCT may kindly be brought to the notice of Directorate General immediately.
- 10. This ruling supersedes Valuation Ruling No.902/2016 dated 08-08-2016 & Order in Revision No.246/2016 dated 30-09-2016.
