DETERMINATION OF CUSTOMS VALUES OF COMPUTER/MULTIMEDIA, TROLLEY SPEAKERS UNDER SECTION 25-A OF THE CUSTOMS ACT, 1969 (VALUATION RULING NO 1969 /2024)

No.Misc/06/2013-VII /308

Dated: 29-03-2024

In exercise of the powers conferred under Section 25A of the Customs Act, 1969, the Customs values of Computer/Multimedia and Trolley Speakers are determined as follows:

2. **Background of the valuation issue:** Earlier, the Customs values of Computer/Multimedia and Trolley Speakers were determined under Section 25A of the Customs Act, 1969 vide Valuation Ruling No.1816/2023 dated 17.10.2023. The Valuation Ruling was challenged under section 25-D before Director General, Customs Valuation, Karachi who passed Order in Revision No. 71/2023 dated 17.10.2023 para 8 thereof states as under:

" In view of the aforesaid discussions/reasons recorded above and in exercise of the powers conferred u/s 25D of the Customs Act,1969 the impugned Valuation Ruling is hereby set aside as found suffers from procedural improprieties/irregularities. The Director Customs Valuation, Karachi is directed to undertake thorough exercise to re-determine value of impugned goods by issuance of new Valuation Ruling, within 30 days, under section 25A of the Customs Act,1969 following the due process of law and after fairly providing the opportunity of hearing to the petitioners."



Keeping in view of the above facts, an exercise was undertaken by the Directorate of Customs Valuation to determine the Customs Values of subject goods in terms of Section 25-A of Customs Act, 1969.

3. **Stakeholders' participation in determination of Customs values:** A meeting was convened on 29.01.2024, which was attended by relevant stakeholders of Computer/Multimedia and Trolley Speakers. The issues pertaining to the valuation of subject goods were deliberated upon in detail in the afore-referred meeting. The importers contended that values of some items especially Mini Mobile Speaker and Multimedia Speaker 2.1 without options, were exorbitantly high in VR No. 1816/2023 dated 17.10.2023 and needed to be rationalized.

4. Analysis / Exercise done to determine Customs values: Ninety (90) days' clearance data was retrieved and the same has been scrutinized. Subsequently, market inquiry has been conducted and examined in the light of this Directorate's Office Order No. 17/2014 dated 19-03-2014 and in terms of Section 25(7) read with Section 25 (9) of the Customs Act, 1969.

Method (s) adopted to determine Customs values: Valuation methods specified in 5. Section 25 of the Customs Act, 1969, are duly considered in sequential order to arrive at the Customs values of subject goods. The transaction value method as provided in sub-section (1) of Section 25 of the Customs Act, 1969, was found inapplicable due to absence of information as required under sub-section (2) of Section 25 of Customs Act, 1969. Therefore, identical goods value method provided in Section 25(5) was examined for applicability to determine Customs values of subject goods. However, it was found that the same could not be solely relied upon due to absence of demonstrable evidences of quantities and qualities. Information available was, hence, found incomplete. Subsequently, similar goods value method provided in Section 25(6) was also examined for applicability to determine Customs values of subject goods. The import data of Computer/Multimedia and Trolley Speakers for the last 90 days was examined. However, Declared Values (DV) of both identical and similar goods showed consistent variations. Hence, this method was also found inapplicable. Market enquiry as envisaged under Sub-Section (7) of Section 25 of the Customs Act, 1969 was also conducted but could only yield results to some extent because of variations in market prices. In line with statutory sequential order of section 25, Computed value method, as provided in Section 25(8) of the Customs Act, 1969 was examined, but the same also could not be applied as the conversion cost from the constituent materials and allied expenses, in the country of export, were not available for manufacturing of Computer/Multimedia and Trolley Speakers. Finally, the Customs values of the subject goods have been determined under Section 25(9), read with Section 25(7), and Customs Rule 121(2) of Customs Rules, 2001 which provides that the methods of valuation, to be employed under sub-section (9) of section 25 of the Customs Act. 1969 may be inclusive of those laid down in sub-sections (1), (5), (6), (7) and (8) of the stid section, but a reasonable flexibility in the application of such methods would be in conformit the aims and provisions of sub-section (9) of that section.

6. **Customs values of Computer/Multimedia and Trolley Speakers:** Computer/Multimedia and Trolley Speakers, hereinafter specified, in **Annex-A (Table-A, Table-B and Table-C)** shall be assessed to duty / taxes at Customs values mentioned therein.

7. Validity of this Valuation Ruling: In cases, where declared values are higher than the Customs values determined in this Ruling, the assessing officers shall apply those values in terms of Sub-Section (1) of Section 25 of the Customs Act, 1969. In case of consignments imported by air, the assessing officers shall take into account the difference between air freight and sea freight while applying the Customs values in this Ruling.

8. Validity of this Valuation Ruling: This Ruling, containing the Customs values for assessment of subject imported goods, shall be applicable until and unless the same are rescinded or revised by the competent authority in terms of Sub-Sections (4) of Section 25A of the Customs Act, 1969.

9. **Revision of the values determined vide this Valuation Ruling:** If aggrieved, a revision petition may be filed against this Ruling, as provided under Section 25D of the Customs Act, 1969, within 30 days from the date of its issuance, before the Director General, Directorate General of Customs Valuation, 7th Floor, Custom House, Karachi.

10. The Collectors of Customs may kindly ensure that the values given in the Valuation Ruling, for the given description of goods, are applied by the concerned assessing officers / officials without fail. Any anomaly observed may kindly be brought to the notice of this Directorate

immediately. The Customs values determined in this ruling are for the descriptions and specifications as mentioned in Para-6 of this Ruling. HS Codes are mentioned for illustrative purposes so that Valuation Ruling is made accessible to the assessing officers. The assessments shall be finalized on the basis of correct classifications after fulfilling all formalities related to importability or other certifications required thereon.

11. This Ruling supersedes Valuation Ruling No. 1816/2023 dated 17.10.2023.
